# **Board of Directors Meeting**

May 6, 2017: 9:00 – 10:00 a.m. Shelly Ridge Service Center

A meeting of the Board of Directors was held on Saturday, May 6, 2017 and began at 9:03 a.m.

## **Board Chair Report/Opening Remarks**

Board Chair, Mary Stengel Austen called the meeting to order. She began by thanking all members for attending the May Board meeting.
