Financial Assistance

\$400,000

Awarded last year to cover membership, girl program supplies, camperships, and program fees to girls in our nine counties.

Camps

Maintains our **seven camping experiences** – four resident and three day camps – as well as helps to provide high-adventure challenges while ensuring that every girl can enjoy the outdoors in a safe environment. Over **\$460,000** was spent on camp maintenance last year.

Programs

Supports all levels of troop and camp programming that encourage each Girl Scout to unleash her inner **G.I.R.L. (Go-getter, Innovator, Risk-taker, Leader)™**. Through the Girl Scout Leadership Experience, girls develop **lifelong skills** through a collection of engaging, challenging, and fun activities like earning badges, going on awesome trips, selling cookies, exploring science (STEM), becoming an entrepreneur, getting outdoors, and doing community service projects.

Volunteer Support

Provides **volunteer resources** and free or reduced-cost **training** to our 15,000 volunteers.
