

The Annual Meeting of Girl Scouts of Eastern Pennsylvania was held on Saturday, May 6, 2017 at Camp Shelly Ridge.

### Call to Order

The meeting was called to order by Mary Stengel Austen, Board Chair, at 10:18 a.m.

### **Opening Ceremony**

#### **Overview of Parliamentary Rules**

The presiding Parliamentarian, Mary Scout, provided an overview of the rules of parliamentary procedure.

Board Secretary, Michael Hanlon, delivered the report of Quorum, noting that Quorum was achieved by a count of ninety-one voting delegates. GSEP Bylaws require 40% or sixty-six voting delegates. In addition, one hundred and eleven Girl Scouts and interested members were in attendance.

The next order of business was to approve the agenda for the meeting. The agenda was approved by unanimous consent.

# Treasurer's Report

Maria Kraus, treasurer, presented the Treasurer's Report. She gave an overview of the financial statements for the year-ended September 30, 2015 and the year-to-date March 31, 2016. Key points covered were:

- GSEP had to restate Fiscal Year 2015 (FY15) to reflect prior period adjustments which were uncovered and corrected during the Fiscal Year 2016 (FY16) audit
- Auditors issued GSEP an unqualified audit which means our financial statements fairly represent our activities for FY16
- 2016 revenue is at \$16,738,421 which is 0.3% lower than the prior year
- 2016 expenses which consist of fund-raising, membership services, camp programs, other girl programs, and general and administrative expenses are at \$16,358,999
- 72% of the gross revenue from Product Program directly benefits the troops, service units, and all the Girl Scouts of Eastern Pennsylvania
- For the first half of this fiscal year, the Council is 67% towards its annual operating goal of raising \$1.7 million in gross contributed revenue
- The three-year Outdoor Program Vision (OPV) project concluded in 2016
  - The total budget of the OPV project was \$11 million and GSEP came in \$68,000 or 0.6% over budget
  - 64% of the project was paid for from the sale of camp properties; 28% was paid by investment liquidation; and 8% was paid for from Capital Campaign contributions

# Management Report

Kim Fraites-Dow, CEO, presented the Management Report, conveying the operations of the Council. Highlights of her presentation included:

  - o 14,513 adult members
  - o 50,676 combined girl and adult membership

# **Board Development Committee Report**
