



The Annual Meeting of Girl Scouts of Eastern Pennsylvania was held on Saturday, May 4, 2019 at Camp Shelly Ridge.

### Call to Order

The Meeting was called to order by Board Chair Debbie Hassan at 10:09 am.

# **Opening Ceremony**

Following a Flag Ceremony, Debbie Hassan presented this year's Governance Award to two recipients: Dianne Rotwitt (not present) and Leslie Stiles.

The Mission Moment was provided by Girl Scout Brownie Matilda M. and Girl Scout Junior Maddie F. of Troop 7886 from Narberth. The girls shared their Take Action project involving decreasing the use of single-use plastics (straws and bags), which led to the town of Narberth becoming the first municipality in the commonwealth to ban the use of single-use plastics.

# **Overview of Parliamentary Rules**

The presiding Parliamentarian, Mary Scout, provided an overview of the rules of parliamentary procedure.

Board Secretary Deb Walters delivered the report of Quorum, noting that Quorum was achieved by a count of 95 voting delegates. GSEP Bylaws require 40% or 70. In addition, 117 Girl Scouts and interested members were in attendance.

The next order of business was to approve the Agenda for the meeting. The agenda was approved by unanimous consent.

### Approval of Minutes Committee

The Delegates, by unanimous consent, approved a Minutes Committee to review and approve the Minutes of the Annual Meeting on behalf of the entire Delegate Body. The committee is comprised of Eve Austin, Mikayla Havers, Diane Nordmark, and Maeve Vogan.

# **Appointment of Tellers**

Board Chair Debbie Hassan appointed Stacy Broad and Linda Mills to serve as Tellers for the meeting.

#### **Governance Report**

Board Chair Debbie Hassan presented the Governance Report, which included reports on:

Spring Delegate Meeting: GSEP's National Council Session Delegates presented four possible
proposals to the Service Unit and Girl Delegates. After explaining their discussions and
rationale for considering each one, the Delegates voted to approve moving forward with the
Proposal to amend Article V, Section 4, which allows for a virtual presence at Special Sessions
of the National Council. The Board voted this morning to approve this proposal as well. The
next steps involve our CEO reaching out to sister Councils to garner their support (we need

15% or 17 Councils to support our proposal); we need to send our proposal and the supporting letters to GSUSA by the end of August.

- Also, GSEP will be accepting applications to be delegates to the 2020 National Council Session in late 2019/early 2020.
- GSUSA's new Cookie PSA ("It's Amazing How Much You Can Learn from a Cookie"). GSEP used these during the 2019 Cookie Sale, courtesy of Comcast and WFMZ.
- Membership grew last year as did the number of girls receiving the highest awards.
- Finally, Debbie Hassan thanked the Girl Advisors (Emma Ciccotosto, Bridgette Lang, and Tamyah Stewart) and final-term Board members (Dianne Rotwitt, Leslie Stiles, and Diane Welsh) for their service.

# **Treasurer's Report**

Maria Kraus, Chair of the Finance Committee, presented the Treasurer's Report on behalf of Treasurer Rick Perkins, who was not present. She gave an overview of the financial statements for Fiscal Year 2018, ending September 30, 2018 and the year-to-date as of March 31, 2019. Key points covered were:

- The auditors found our records to accurately represent our activities for Fiscal Year 2018.
- The total revenue in Fiscal Year 2018 reflects an overall decrease compared to prior year, primarily attributable to the shortfall in the cookie program. GSEP actively managed offsetting expense reductions is Fiscal Year 2018 and, as a result, managed to deliver a \$71,000 surplus in 2018.
- The operating revenue in Fiscal Year 2018 was lower than the previous year, mainly due to a shortfall in the Product Program sales. Total operating revenue was lower than the prior year by 6% or 1.09 million dollars. Earned revenue decreased by more than 1.15 million dollars primarily because of the shortfall in product program (Cookies and Nuts About Reading). Contributed revenue, however, increased slightly over prior year.
- The operating expenses for Fiscal Year 2018 totaled \$16,607,706. Over the past four years, our direct girl program expense allocations have been trending favorably, increasing from 72% in 2015 to 83% in 2018.
- Product Program gross revenue totaled \$16,120,039. 71% of this revenue directly benefits troops, service units and all the Girl Scouts of Eastern Pennsylvania. Last year, more than 3 million dollars was directed back to troops and service units and 454 thousand dollars were used for recognitions including older girl travel, adventure credits and mystery tours.
- For the first half of this fiscal year (FY2019), total revenue is pacing behind goal. The Key Performance Indicator is a 7% shortfall in the Cookie Program this year. A lower number of registered girls and a lower participation rate compared to budget resulted in less girls selling cookies than projected. Due to the shortfall in revenue, management has applied tighter controls on spending. And, GSEP is focused on reversing the revenue trend by concentrating on areas that are still able to move in the second six months of the fiscal year, like fundraising, camp and other girl programs, facility rentals, and retail sales.

### **Management Report**

Chief Executive Officer Kim E. Fraites-Dow presented the Management Report, conveying the operations of the Council. Highlights of her presentation included:

- An overview of Year 2 of the 2016-2019 Strategic Plan (more details can be found in the 2018 Annual Report)
- Sharing the new Core Goals of Movement, Membership, and Money

# **Board Development Committee Report**

Board Development Committee Chair Susan Mucciarone presented the report of the Board Development Committee, which included the committee's charge and the processes behind their work. It also covered:

- The Board Development Committee is comprised of four Board members and five non-Board members.
- The priorities this year consisted of candidates who represented diversity in all its forms, the STEM field, and non-profit governance.
- The Girl Governance subcommittee of the Girl and Volunteer Experience Committee reviewed more than 65 applications for the Girl Advisor and Girl Delegate positions. They had worked on streamlining and updating the application process, which included a new question: In 50 words or less, what else would you like us to know about you? Their suggested slate, which was approved by the Board Development Committee, includes candidates who reflect the diversity of our council in terms of geography, Girl Scout awards, grades, race/ethnicity, and governance experience

The Board Development Chair did not receive notification of any nominations from the floor for Officers, Members-at-Large, Girl Advisors, or Girl Delegates. The 2019-2020 Slate was presented to the Delegate Council, including 6 Officers, 15 Members-at-Large, 3 Girl Advisors, 6 Board Development Committee Members, and 30 Girl Delegates.
