Continuing Governance Education

Ever wonder why there is a single slate presented at the Annual Meeting, rather than voting on each nominee?

The simple answer is that our [Bylaws](#) (Article V, Section 3 a & b) state that the Board Development Committee “must present a single slate of nominees.” This is also reflected in Article XII, Section 9 of the [Blue Book of Basic Documents](#), the foundational reference provided by GSUSA for Girl Scout governance. It contains the Constitution, Bylaws, Policies, Credentials, and Congressional Charter of GSUSA as well as criteria and standards for an effective Girl Scout council.

A more robust answer is that presenting a single slate is a preferred good governance practice. The Board Development Committee (BDC) has a strategic perspective

and detailed data on the current and future needs of the Board of Directors. The BDC (also elected by the Delegate Council) has the responsibility to identify, cultivate, and recruit candidates whose skills and talents can positively and concretely contribute to the Council.
