#### Fall Delegate Council Meeting being held on September 28

The first Delegate Council Meeting of the Governance Year is happening later this month. The Fall Delegate Council Meeting will happen VIRTUALLY on September 28, from 7-9 pm via Zoom. know this is early! But the proposals are due to GSUSA this upcoming spring).

## <u>Training for NEW Delegates (Service Unit or Girl Delegates)</u> <u>scheduled for September 18</u>

Welcome to all our new members of the Delegate Council! To get the most robust experience from your Delegate service, it helps to be educated about your new role. We're excited to offer an in-person training again this year! (FYI - If you have previously served as a Delegate and have already taken the training, no need to do it again.)

Please join us on September 18, from 9:30-11:30 am via Zoom for the training for new Delegate Council members. One of GSUSA's National Volunteer Partners in Governance will be hosting the training, so you'll all be learning from a nationally recognized expert. We will explain your governance role, our Bylaws and the part they play in GSEP's organization, GSUSA's Blue Book, and how we all work together to improve our Movement on a strategic level.

## <u>Service Unit Delegate Elections – results were due August 31, 2021</u>

As you know, SU Delegates are elected annually to serve one-year terms, which run from Annual Meeting to Annual Meeting. Every summer, we ask for confirmation of all Service Units' delegates. This is vitally important now, because of the upcoming Fall Delegate Council Meeting. (This is one of only three meetings required of SU Delegates.) As of the August 31st deadline, only 30% of the Service Units had emailed the SU Delegate Election form in to governance@gsep.org. If your Service Unit is on this list, your SU Delegate Election Results form has not been turned in!

Therefore, if you have not already, please elect your Service Unit Delegates for the new Governance Year this month! Please check out

the following information to make your elections go smoothly (all of which can also be found in the tab at the bottom of the Governance page of our website):

- The SU Delegate Election Results Form this must be downloaded, completed, saved, and emailed to governance@gsep.org ASAP!
- The list of Service Units entitled to one or two SU Delegates.
- Please remember:
  - If your SU Delegate served in the 2020-2021 Governance
    Year and is interested in returning in that role, they still must
    be elected to serve in the 2021-2022 Governance Year. A
    Service Unit Delegate (or Alternate) can serve up to six
    consecutive one-year terms.
  - A Service Unit Delegate can be an older girl! This is a great opportunity for girls 14 years or older to learn more about the Council on a strategic level (and it looks great on a college application!).
  - This position requires only 3 meetings a year: the Fall Delegate Meeting in late September; the Spring Delegate Meeting in March; and the Annual Meeting in early May. A Delegate training will also be offered in the fall to orient new folks to the position.

## <u>Public Service Reminder – Deadline to Register to Vote in PA is</u> October 18

Just as you are interested and involved in governance here in GSEP, as an American citizen, you are all encouraged to also be an active participant in civic governance as well...and one of the most efficient and effective ways to have your voice heard at the local, state, and federal levels is to vote. The first step in this process is actually registering to vote. If you aren't registered yet, please check out Pennsylvania's Online Voter Registration page and complete the form. The deadline to register to vote so that you can fill out a ballot on November 2nd is October 18.

#### **Continuing Governance Education**

#### What do Board Committees do?

GSEP has six standing committees, made up of both Board and non-Board members, who are appointed by the Board Chair (with one exception). They are: Board Development, Executive, HR, Finance/Audit, Membership Strategy, and Property (two of which are explained in detail in the Bylaws). There are also a few subcommittees and ad hoc task forces created to work on specific issues and tasks.

The **Board Development Committee** is elected by you, the Delegate Council, at the Annual Meeting. This group of nine people create the slate of nominees for Officers, Board members, BDC members, Girl Advisors, Girl Delegates and every three years, NCS Delegates. This means they identify, cultivate, and recruit candidates. They are also responsible for educating new Board members to ensure they know their responsibilities. More info can be found in Article V of the Bylaws.

The **Executive Committee** includes the Officers of the Board and two Board Members-at-Large, approved by the Board as a whole. This group has the authority of the Board between Board meetings. Article VI of the Bylaws has more information on the Executive Committee.

The **Human Resources Committee** acts as an HR resource for the CEO and HR staff team. This group also reviews HR-related policies and has a primary responsibility to review and discuss the CEO's annual performance assessment conducted by the Board Chair.

Having the **Finance/Audit Committee** is required by our Bylaws (Article III, section 3.h.). They give guidance for all policy decisions pertaining to financial plans and business investments for the council. For example, they review the annual operational and capital budgets, assess the effectiveness of council use of resources, review and monitor the council's income stream and business investments, and oversee fiscal year-end audit (which is required by our Bylaws in Article VII, section 5).

The **Membership Strategy Committee** is a relatively new committee, and they are tasked with providing guidance and assistance to increase the visibility of Girl Scouting within our nine-county footprint.

The **Property Committee** is responsible for providing strategic direction and advice to the CEO and staff regarding the short and long-term development, stewardship and use of Council properties. This includes our Service Centers and all our camps.

You can read more about their specific work when you peruse the Board Meeting Overviews on the bottom of the Governance page of the website, since the Committees are required to report on their work to the Board.
