

Annual Meeting Minutes May 2, 2020

The Annual Meeting of Girl Scouts of Eastern Pennsylvania was held virtually on Saturday, May 2, 2020 via the online platform GoToWebinar and using a voting mechanism via the online platform Qualtrics.

Call to Order

The Meeting was called to order by Board Chair Debbie Hassan at 10:08 am.

Opening Ceremony

The meeting started off with the Pledge of Allegiance, Girl Scout Promise, and Girl Scout Law led by the Girl Advisors to the Board.

Mission Moments

First, Debbie Hassan presented the Governance Award to Deb Walters, a second time recipient, for her outstanding work on the Bylaws Committee. Deb W. thanked the Council for the recognition and appreciation gift.

Then, Mosey Wood Camp Director April "Ape" Beattie spoke on the adaptations the Girl Experience team has made due to the public health crisis. An example she shared was the camp directors and staff have held Zoom calls on Saturday nights to bring Girl Scout campers together virtually. The campers have enjoyed a talent show, making s'mores. and singing camp songs together. The photograph shown during Ape's remarks was a young Girl Scout toasting a marshmallow while participating in the Zoom meeting on her laptop.

CEO Opening Remarks

CEO Kim Fraites-Dow first wished all attendees continued good health and expressed gratitude for all our girls, volunteers, and families who are working or supporting those on the front lines of the public health crisis. She also thanked everyone for joining today's first virtual Annual Meeting and announced that we had the most attendees ever. She then shared the three phases of GSEP's COVID-19 Emergency Action Plan.

Phase I started on March 13th with the mandate that staff work from home and all in-person programming was cancelled through May 11th. The cookie sale was finalized, and the Lehigh Valley Service Center was sold during this period (as already planned). Phase II involved launching Girl Scouts at Home, virtual programming for girls and virtual training for volunteers. More than 40% of the staff was involved in this initiative. An audit of work and current personnel was conducted. The Finance team secured a Small Business Administration Payroll Protection Plan Loan, which allowed for the retention of all full-time staff. All Girl Scout in-person programming was cancelled through June 19th and summer camp is now delayed by two weeks. Phase III is about creating a stronger GSEP for the remaining 80 staff to remain focused on providing ongoing virtual Girl Scouts @ Home programming for all age levels and supporting volunteers so they can also continue to lead their troops virtually.

Overview of Parliamentary Rules & Confirmation of Quorum

The presiding Parliamentarian, Mary Scout, provided an overview of the rules of parliamentary procedure, and she included caveats about operating in a virtual environment.

Board Secretary Deb Walters delivered the report on Quorum, noting that Quorum was achieved by a count of 152 voting delegates. GSEP Bylaws require 40% for quorum or 72 voting delegates. In addition, a record number of Girl Scouts and interested members were in attendance.

Approval of Agenda & Minutes Committee

Board Chair Debbie Hassan explained that the next order of business was to approve the Agenda for the meeting. The agenda was approved by a vote of 147 in favor, 0 against.

The Delegates then approved a Minutes Committee to review and approve the Minutes of the Annual Meeting on behalf of the entire Delegate Body. The vote was 146 in favor; zero opposed. The committee is comprised of Karen Harris, Megan Hughes, Kristin Kolody-ladicicco, and Olga Torres.

Appointment of Tellers

Board Chair Debbie Hassan appointed Charlene Reidy as Head Teller and Cassie Grow, Alexa Iannace, and Linda Mills to serve as Tellers for the meeting.

Governance Report

Board Chair Debbie Hassan presented the Governance Report, which included reports on:

- Delegate Meeting recaps, including an overview of GSEP's improved Smoking Policy, Social Media policy and Bylaws
- 2020 National Council Session News and Proposals:
 - o The National Board has decided to hold a virtual National Council Session in October
 - NCS Proposals to be voted on this year are:
 - Establish a task force to determine the viability of developing a Gold Award Scholarship Foundation.
 - Establishing consistency of delegate terms across the Movement
 - A lifetime membership discount for volunteers who have served 10+ years
 - Changing Membership Dues: National Board first needs input from the National Council
 - Changing Membership Dues: National Board must communicate the intended use of the funds and the impact on the movement prior to any changes.
 - Changing Membership Dues: for an increase of 25% or more, the National Board MUST seek approval from the National Council
- The Governance report concluded with Special Acknowledgements for the Girl Advisors to the Board: Nya, Sydney, and Brianna.

Treasurer's Report

Treasurer Rick Perkins presented the Treasurer's Report. He gave an overview of the financial statements for the year-ended September 30, 2019 and the year-to-date as of March 31, 2020. Key points covered were:

• The auditors have issued GSEP an unmodified (or, favorable) financial outcome report for Fiscal Year 2019.

- Fiscal Year 2019 had revenue of \$16,871,067 (2% higher than FY2018) and expenses of \$16,653,258, resulting in a surplus of \$200,000.
 - o Earned revenue increases were primarily from a successful cookie sale and a strong camp season. Contributed revenue increased by \$128,000 from the three Take the Lead events.
 - o 84% of the expenses in FY2019 went toward programs for girls

Rick then highlighted the Product Program (Cookie Sale) and explained that this is the largest girl-run business in the world and helps girls develop five essential life skills. The Cookie Sale Program gross revenue was \$16,028,415 in FY2019.

 84% of the revenue from cookie program sale directly benefits troops, service units and all Girl Scouts in our Council

Rick also shared the status of Year-to-Date FY 2020 (as of March). In the first half of the year, GSEP is 2% ahead of goal, tracking \$400,000 ahead of budget due to a successful cookie sale ending before the COVID-19 crisis. During this year's cookie sale, our girls sold 144,000 more boxes than 2019. The per girl average was 25 boxes higher than in 2019.

Attendees were able to type in questions in the chat log and CFO Michael Vanic and CEO Kim Fraites-Dow responded:

- Q: Assuming pandemic lasts through summer, could that lead to a deficit for the year?
 - A: There will be a shortfall for revenue for camp & programs, but we still expect to have a surplus.
- O Q: What is an example of a benefit to troops?
 - Cookie proceeds pay for cost of goods, troop benefits, girl and adult recognitions, and benefits to all girls e.g., weekend programming, camp programming and maintenance, etc.
- Q: Will additional scholarships be offered?
 - A: There are many different scholarships that the girls can apply for and financial aid is always available to those in need.

Management Report

CEO Kim Fraites-Dow presented the Management Report, reporting on the operations of GSEP during Year 3 of the three-year strategic plan (2016-2019). The plan has 7 guiding principles: Leadership, Community, Service, Inclusion, Respect, Integrity, and Innovation. The vision is for GSEP to be known as the premier leadership organization for girls that is driven by an engaged community of volunteers, members, alumnae, partners, and staff, and supported by an organizational culture of service, learning, and growth.

Highlights of her presentation included:

 Goal 1 (Our Organization): A major focus was on defining diversity, equity, and inclusion, for GSEP, and understanding what communities are underrepresented. Priority was given to increasing the number of Latina, African American and Asian staff, volunteers and girls. Recruitment plans were developed and leadership inclusion training for staff, volunteer, members and board were developed and implemented to encourage a comfortable environment for all members. Service center spaces were updated to be more welcoming and inclusive; for example, the front desk/shop area was updated and a new Friendship Corner room at Valley Forge was created.

- Goal 2 (Communications): GSEP expanded its social media marketing efforts with a call to action
 deliverable, resulting in an increase of followers, new/renewed memberships and enhanced
 communication with parents, alumni, girls and funders. The Communications Focus Group
 provided feedback on the ideas for the Spring renewal campaign, county-specific marketing
 tools, and camp offerings. GSEP also focused on promoting the Girl Scout Gold Award and gave
 access to Gold Award press releases, media contacts, and promotional social media tips to girls
 and volunteers.
- Goal 3 (Girl Experience): A Girl Program steering committee was created with older girls providing impact information to improve the Girl Scout experience. They helped co-create programs like the girl track at the 2020 Women's Leadership Summit. GSEP engaged 12,447 girls in various GSLE programs, and 4,635 girls attended summer camp in 2019. 94% of campers surveyed said they would recommend camp and 92% said they would return. They also reported feeling more confident and able to take charge. Plus, 437 girls were honored as 2019 Cookie Bosses (those girls sold 1,000+ boxes) and 350 girls were added to the 500 Club.
- Goal 4 (Volunteer Experience): The Volunteer Support team provided enhanced relationship management and support to Service Unit Managers and Troop Leaders. GSEP also offered more consistent communications to new Leaders and other volunteers via weekly newsletters and monthly virtual meetings. GSEP also revised and expanded its resources for volunteers, including the Volunteer Tool-Kit Guide, a searchable web version of Volunteer Essentials, the Leader's Guide to Success, a Family Guide for new members, updated Product Program manuals, and regionalized Spark Program Guides. GSEP saw a 12% increase in learning facilitators, representing a more diverse community. More options for in-person and online training for new leaders were offered.
- Goal 5 (Financial Sustainability and Revenue Enhancement): GSEP provided additional resources
 to improve facility rentals for service units, troops and outside groups that resulted in a 53%
 increase in utilization. Plus, as was reported earlier in the meeting, functional expense ratios for
 Girl Scout programs over the past five years moved from 72% in Membership Year 2015 to 84%
 in Membership Year 2019.

Kim shared that a more comprehensive overview of Year Three of the Strategic Plan can be found in the 2019 Annual Report, which will be available on GSEP's website immediately following the Annual Meeting.

Board Development Committee Report

Board Development Committee Chair Susan Mucciarone presented the report of the Board Development Committee, which included the committee's charge and the processes behind their work. Susan also explained that two subcommittees identified candidates for the National Council Session Delegate and Girl Delegate positions with an emphasis on diversity of age, county, race/ethnicity, and governance experience. She then presented the slates to the Delegate Council, including 6 Board Members-at-Large, 3 Girl Advisors, 3 Board Development Committee Members, 30 Girl Delegates, and 25 National Council Session Delegates, along with 3 Alternate NCS Delegates.

Vote on the new proposed Bylaws

Deb Walters, chair of the Bylaws Committee, reported that the committee has met for the past 8 months to discuss updates to the GSEP Bylaws, starting with the 139 comments and questions generated at the Fall (2019) Delegate Meeting. The proposed Bylaws would be the first significant update in 13 years. The Bylaws Committee educated and shared with the Delegates their process through educational outreach including newsletters and a webinar. Three areas of focus were to create clarity, include definitions, and make substantive changes to bring the Bylaws up to date with the Council's needs. Deb Walters then moved for the adoption of the updated Bylaws on behalf of the Bylaws Committee.

The vote on the adoption of the new revised GSEP Bylaws required 2/3 approval by the Delegate Council or 120 votes. While Delegates were submitting their vote, a short video created by Cadette Troop 8133 in Northampton County was shared.

The new Bylaws were approved by 136 votes in favor (one vote opposed); therefore, they are adopted as of May 2, 2020 and in effect immediately.

Board Chair Debbie Hassan also authorized the Bylaws Committee to correct any punctuation, article and section designations for cross referencing purposes and other technical and conforming changes as may be necessary to reflect the intent of our organization with the adoption of our new Bylaws. There were no objections from the Delegate Council to this statement, so the authorization by the Board Chair stands.
