Why is GSEP's Annual Meeting held in May?

entire Movement are discussed, debated, and voted upon. Yet, GSEP hosts our most important governance meeting every year. Why? First, GSEP is a separate, independent legal entity (or 501c3 nonprofit) from GSUSA. GSEP has its own Bylaws, Board of Directors, and CEO. However, since

we are chartered by GSUSA, we -- and all chartered Girl Scout Councils -adhere to the same Membership/Fiscal Year (October 1-September 30).

Girl Scout Councils throughout the country hold their Annual Meetings at

various times throughout the Membership/Fiscal Year. Most hold theirs some time between January – May. Here is Pennsylvania, <u>state statutes</u> do require that 501c3 nonprofits hold a governance meeting annually, as prescribed by

Girl Scouts of the USA (GSUSA), our parent organization, has their most

important governance meeting triennially (or, every three years). That is the National Council Session, where National Board members and National Board Development Committee members are elected and topics that may impact our

each group's respective Bylaws. GSEP's Bylaws state that we must hold our Annual Meeting "between April 1 and June 1" (Article 2, Section 7, line 80-82). In the past decade of our 17-year existence as Girl Scouts of Eastern PA, we have settled on the first Saturday in May as the best date to host our Annual Meeting. This timeframe allows the Board time to review and approve financial reports (the previous year's Fiscal

Year Audit and 990), which inform both the Treasurer's Report and the CEO's State of the Council report presented at the Annual Meeting. Plus, hosting the
