



# COVID-19 Waiver of Liability and Indemnification



I agree that I am personally responsible for my safety and my minor child's \_\_\_\_\_ (print child's name) safety while taking part in Girl Scout activities with Troop # \_\_\_\_\_ ("Troop Activities"). I understand that, other than general cleaning before my child's arrival, neither the Troop Leader, nor Girl Scouts of Eastern Pennsylvania ("GSEP") undertake any COVID-19 cleaning. Because Troop Activities are open for other individuals, I recognize that I am at higher risk of contracting COVID-19. I also agree, that in the event anyone in my immediate family has been diagnosed with a confirmed COVID-19 diagnosis, I will advise the Troop Leader immediately, and refrain from in-person Troop Activities for a number of days (in accordance with the most up-to-date CDC guidelines) from diagnosis/positive Covid-19 test result. Further, I agree, for myself and my minor child, that:

1. With full awareness and appreciation of the risks involved, I, for myself, and on behalf of my minor child, hereby forever release, waive, discharge, and covenant not to sue Troop Leader and/or GSEP, or their agents, servants, volunteers, employees, successors, assigns and/or any others taking part in Troop Activities (collectively the "Released Parties") from any and/or all liability, claims, demands, actions, and causes of action whatsoever, directly or indirectly arising out of or related to any loss, damage, or injury, including death, that may be sustained by me or my minor child related to COVID-19, whether caused by the negligence of the Released Parties, or otherwise, while participating in any Troop Activities.
2. I agree to indemnify, defend, and hold harmless the Released Parties from and against any and all costs, expenses, damages, claims, lawsuits, judgments, losses, and/or liabilities (including attorney fees) arising either directly or indirectly from or related to any and all claims made by or against any of the Released Parties due to bodily injury, death, loss of use, monetary loss, or any other injury from or related to my or my minor child's participation in Troop Activities, whether caused by the negligence of the Released Parties or otherwise specifically related to COVID-19.
3. By signing below I acknowledge that I have read the foregoing Waiver of Liability and Indemnification ("Waiver"), understand it and sign it voluntarily as my own free act and deed, including without limitation the Release of Liability and Indemnification requirements contained in this document; I am sufficiently informed about the risks involved in participating in Troop Activities, to decide whether to sign this document; no oral representations, statements, or inducements, apart from the foregoing written agreement, have been made; I am at least eighteen (18) years of age and fully competent; and I execute this document for full, adequate, and complete consideration fully intending to be bound by the same. I agree that this Waiver shall be governed by and construed in accordance with Pennsylvania law, and that if any of the provisions hereof are found to be unenforceable, the remainder shall be enforced as fully as possible and the unenforceable provision(s) shall be deemed modified to the limited extent required to permit enforcement of the Waiver as a whole.
